Subject :- Display of Adverse Drug Reaction (ADR) reporting QR Code in all Pharmacy Educational Institutions, Medical Shops, Hospitals and by registered pharmacists.

The Indian Pharmacopoeia Commission (IPC) and The Jharkhand State Pharmacy Council have entered into Memorandum of Understanding (MoU) to promote pharmacovigilance programme of India and to encourage the Adverse Drug Reaction (ADR) reporting across the state.

In order to create awareness among healthcare professionals and the general public and to facilitate easy reporting ADR, it is hereby directed that the ADR reporting QR code shall be prominently displayed by all concerned as per the following instructions :-

1. All Pharmacy Educational Institutions shall display the ADR reporting QR code at the locations such as the entrance, Notice boards, Pharmacy dept. laboratories, libraries and other common areas of the institute campus.
2. All medical shops (Retail and wholesale) shall display the ADR reporting QR code at a clear visible place within their premises so that patient and general public conveniently report suspected adverse drug reaction.
3. All Government and Private Hospitals, Nursing Homes and other healthcare institution shall display the ADR reporting QR code in OPDs, IPDs, hospital pharmacies, registration counter and other appropriate locations.
4. All registered Pharmacists are encouraged to create awareness among patients and general public regarding the importance of reporting Adverse Drug Reaction (ADR).

The above initiative is aimed at strengthening patient safety, promoting the safe use of medicines and supporting pharmacovigilance programme of India (PvPI). This office order issues with the approval of competent authority.

This office order shall come into force with immediate effect.
